# 2020 Election Update -Overturning the Hyde Amendment

Biden is making the case that federal

funding for abortion is healthcare.

Perhaps you have read that former Vice President, and former U.S. Senator, Joe Biden has announced his opposition to the Hyde Amend-

ment. This is significant in any circumstance. But it is all the more significant in that Biden is currently the leading candi-

date to secure the nomination for president by the Democrat Party.

The Hyde Amendment first became law of the land in 1976 and prohibits the use of federal funds in paying for abortion. In 2016, the Democratic Party platform, for the first time, explicitly called for the repeal of the Hyde Amendment.

Joe Biden, who supported the Hyde Amendment throughout his whole political career, now, as he runs for the Democratic nomination in 2020, has

announced that he opposes

it. In explaining his rationale for this change in stance, Biden reiterated his support of abortion, his

support and commitment to Roe v Wade as law of the land, and went on to explain that in that he supports universal government healthcare, and Biden is making the case that federal funding for abortion is healthcare.

How is destroying life – killing of the innocent or murder, if you will, health care? Sadly, this is now

an accepted part of the lexicon of the left. Abortion, the destruction of innocent human life, is called health care. That Joe Biden and the Democratic Party buy into this horrible and gross distortion is not news, however. Joe Biden and his party have taken this a step further. Not only is abortion health care in their view, and a constitutionally defined right, but a right they now CLAIM then trig-

### Planned Parenthood Update - Ky Again Denies Abortion Facility's License

Kentucky Governor Matt Bevin's administration has denied a license to perform abortions to the Planned Parenthood facility in downtown Louisville. This marks

the second time the administration has denied Planned
Parenthood in Louisville a license. Kentucky's Cabinet
for Health and Family Services
informed Planned
Parenthood via letter on August 16, 2019, the state denied their license because the facility performed 23 abortions
without a license between December, 2015 and January, 2016.

The state first denied the facility's license to perform abortions under a 1998 state law requiring abortion providers to have what are known as "transport" and "transfer" agreements with an ambulance services and hospitals in the event of medical emergencies.

U.S. District Court Judge, Greg Stivers, struck down that law in 2018 as unconstitutional, a decision the state has appealed.

Judge Stivers said that Transfer Agreements "do not advance a legitimate interest" in promoting the health of women seeking abortions. Stivers further wrote

in his 60-page ruling, "On the other hand, the regulations effectively eliminate women's rights to abortion in the state. Therefore, the challenged regulations are unconstitutional." We find Judge Stivers ruling to be unconscionable.

Kentucky Right to Life applauds Governor Bevin for pushing forward on the goal of no more abortions in Kentucky. Right to Life hopes Kentucky will become the first abortion-free state in the nation. For perspective, Kentucky still has one abortion facility open for business in Kentucky. The EMW Women's Clinic on Market Street in Louisville still does abortions Monday-Saturday.

In June, 2016, Governor Bevin announced the closing of the unlicensed abortion facility on Burt Road in Lexington, the EMW Women's Clinic. His action was immediately challenged in court but the Appellate court judges issued a unanimous ruling which found that Fayette Circuit Judge Ernesto Scorsone's previous decision to allow an unlicensed facility to continue operating was "clearly erroneous". The judges had little difficulty in determining that the evidence showed that EMW Lexington was operating an unsanitary clinic that, despite its owner's protestation's that EMW was merely a "private physician's office," was solely an abortion clinic and had been since at least 2011. In January, 2017, EMW in Lexington was permanently closed.
